2. Prepare the additional items which will make a complete application package:
 - **Letter of interest** with a statement that describes your proposed topic or approach during your time in the residency, what attracts you to a collaborative residency like this, and what guided your selection of Participating Agency Teams – 2-page limit
 - **Examples of previous work**, labeled and succinctly described, in a format that suits the artistic work (e.g. up to 5 images, up to 5 pages of text, or a link to up to 5 minutes of audio/ video)
 - **Three references** of people familiar with your work, with phone and email address listed
 - **Resume or CV**
3. Combine these completed items as a **single combined PDF**
4. Send the single PDF of application package to NYCUFSArts@parks.nyc.gov with the subject line "UFS Artist Residency Application" by **September 15th, 2020**
5. Applicants will be notified by the end of October, 2020
